- Brittney Mack and the 5th-grade team: \$1,260 for tickets to an Indy Fuel Game for 5th graders.
















New Scholarships

Mike and Donna Esteb McElwain, supports graduates pursuing careers in Law Enforcement, Criminal Justice or Nursing with the Michael L. McElwain and Donna J. (Esteb) Scholarship. Mike graduated from Whiteland Community High School in 1969 and from the Indiana Law Enforcement Academy. He served 43 years with the Johnson County Sheriff's Department, retiring as a lieutenant. Donna graduated from Whiteland Community High School in 1971 and from Indiana Central College (now the University of Indianapolis) with a major in nursing. She worked more than 40 years as a registered nurse at Riley and St. Vincent hospitals. They wish to give back through this \$1,000 annual scholarship, renewable for four years. 
